Hardware Bag Contents for F043LH and F045LB:

- 2) 1 1/2" x 5/8 Bolts
- 2) 15/16 Nuts
- 2) 2" Washers

Recommended Tools:

15/16 wrench and socket

Step 1. Locate the two plastic inserts in each corner of the bumper opening, remove and discard. This will expose a factory mounting location behind the bumper on both sides.

NOTE: The mounting locations will be a round hole through a metal plate on both sides.

Step 2. Match up the light bar brackets to the factory mounting holes through the bumper. Next, start a 1 1/2" x 5/8 bolt, 15/16 nut, and 2" washer and hand tighten. Repeat on other side. This concludes the installation.
